The Chairman: Welcomed the members stating pleasure at a good turn out. #### **Reports:**

**Chairman:** Read excerpts of the letter to Bob that expressed concern that Bob was getting stretched thin with his many other commitments and most notably, the health of wife Sheila. These priorities have lessened the opportunities to participate in association inter-committee business. The chairman emphasized that we owed Bob our thanks and appreciation for his over 10 years of outstanding voluntary service to the association as the Treasurer, hoping that he will now come to meetings and be able to sit back and relax with a beer and enjoy the company of friends. In the meantime the secretary had taken on the duties of treasurer along with secretary duties. Members were informed that another member would be asked to join the executive in keeping with the constitution. (Eric "Scottie" Parsons has agreed to accept this position)

Secretary/ Treasurer: Reported 144 members in good standing; consisting of 95 paid for 2005; 45 life and 4 retirement memberships.

Financial: For the period ending May 20, 2005. Credits: \$ 433.03; Debits: \$ 150.83. Operating account \$ 3,880.05. Ladies fund at \$ 350.00. Giving a bank balance of \$ 4,230.05. There are 4 G. I. C's with a total value of \$ 14,953.66.

Slops on hand have a retail value of \$ 5,965.00 (this is to be confirmed by an updated stock inventory) This gives total assets of \$ 25,148.71. We also have the 3 Soap Stone carvings with an unknown value. Motion that the Treasurers report be accepted as given; made by Luc Rollin; seconded by Pierre Alarie. Motion Carried.

**Health/Wellness & Slops:** Reported that he has 15 new blazer badges in stock, should have Beret badges by the next meeting. Chairman noted that some slops such as JR pins are to be taken to the BBQ at Central where sales should be favourable.

**Social:** Mess Dinner: **Thursday 14 July, 2005. Time: 1800 for 1900.** Rep. stated that a lot of people had not paid up, asking that those in attendance who have not paid please do so before leaving, he will be contacting those who are not present reminding them to get their cheques in the mail. He then passed around a menu with the selected salad; entree and dessert highlighted; there will be a choice of red or white wine, with port for the toasts.
